We welcome proposals from new and experienced researchers. Below you will find the conference theme, general requirements for NERA proposals as well as specific guidelines corresponding to the four session formats. Conference Theme: "Honoring the Past in Educational Research, While Looking Ahead: What Does the Future Hold?"

"Oh, how quickly we forget" is a quote that my parents would use when nudging my complaining siblings and me to consider all of the good things they've done for us. They wanted to teach us not to forget the sacrifices made or the hard work that went into creating the environment that we currently enjoy. The production of educational research can be traced back to the mid-19th century in America. Since this time, researchers have been able to stand on the achievements of peers that have come before them for the sole purpose of achieving more in the field of education. These achievements have been seen in educational research methodology, technology, and in more effective and efficient educational practices. Even more, the expansiveness of educational research has allowed us to investigate the impact of our educational systems and interventions on groups of students that truly reflect the diversity of our nation.

These past achievements in educational research will help today's researchers build the logical case for their papers and presentations at the annual NERA Conference. By reflecting on the past work of our peers, we can better appreciate the hard work in research and in practice that has led us to this moment. This solid foundation, built by previous research will allow today's researchers to be bold in their assertions about the future, with the security of knowing that the hard work will continue.

Submission Requirements

- Complete information for author(s) including affiliation(s)
- Descriptive title (**maximum: 15 words**)
- Three keywords
- Description of paper to appear in the conference program (**maximum: 50 words**).
- Proposal, NOT including tables, figures, and references (**maximum: 1000 words**).
 - The proposal should include: study purpose, theoretical framework, methodology, results, conclusions, and educational implications. *Only completed or nearly completed (i.e., all data collected, most analyses completed and summarized) research will be accepted.*
 - *Note:* Refer to the Proposal FAQ for details about the organization for proposals that may not lend themselves to each of the sections listed above
 - Warning: Proposals with more than **1000 words** will not be accepted.

Submission Format

The proposal submission form is currently online and accessible on the NERA website. At the time of submission, authors will be required to select from a list of descriptive keywords to categorize their proposal.

Submission Review Process

- Proposals *must* be submitted electronically by **Monday, June 4th, 2018 (11:59pm EST)**.
- 2 to 3 NERA members will blindly review each proposal.
- Each proposal will be judged according to the following criteria: educational or scholarly significance, perspective or theoretical framework, appropriateness of methodology, clarity of expression, and appeal to NERA membership.
- Proposal decisions will be emailed to first authors in mid-August. Details about session dates and times will follow when the program is finalized.

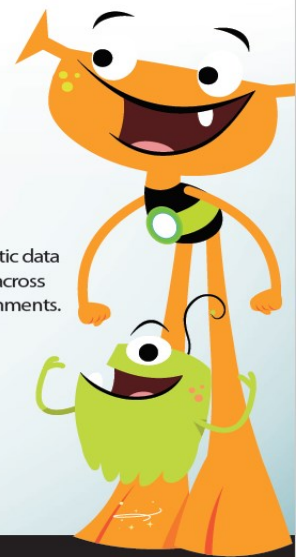

2018 Winter NERA Board Meeting — Highlights

The NERA Board of Directors convened for the Winter NERA Board meeting on January 19-20, 2018 at the Trumbull Marriott in Trumbull, CT. Below are some highlights from the Board meeting:

- The Board reviewed and approved the October 2017 Board Meeting minutes.
- Steven Holtzman presented the Treasurer's Report on the 2017 budget and the proposed 2018 budget. He went over the details of the operational budget and raised questions for the Board to consider regarding NERA funds. For example, should we switch to a more nationally recognized bank? Should we set up a savings account? Should we have a NERA credit card? Steven and the Board discussed the need for a long-term plan for NERA funds. A committee was formed with Ross Markle as the chair and Tia Fetcher, Craig Wells, and Steven Holtzman as co-chairs. Tia Fetcher was introduced as the next Treasurer starting January, 2019. This year will be a shadow year for Tia.
- Craig Wells presented the 2017 conference debrief on behalf of the 2017 co-chairs and discussed the total expenses and income from the 2017 conference as well as issues around workshop attendance.
- Tabitha McKinley and Jade Caines Lee (2018 conference co-chairs) presented the 2017 conference survey results and provided a summary of all of the 2018 conference planning activities. Be sure to attend this year's conference so that you can experience all of the exciting activities they have planned!
- NERA President, Javarro Russell, led a discussion on the NERA proceedings on behalf of the 2017 co-chairs. In short, very few papers are submitted to the NERA proceedings.
- Nina Deng presented *The NERA Researcher* Report on behalf of the co-editors, Katrina Roohr and Katherine Reynolds. There are concerns about receiving the articles on time. One of the issues contributing to this has to do with not having up to date information on who is the chair of a committee and/or who is new to the Board/cycled off. There is a need to formalize a process to note who is in what position.
- Javarro led a discussion around the role of Board Members as liaisons and proposed developing action items that would be a work in progress by the summer Board Meeting.
- Andrew Jones presented the Communications Committee Report on behalf of Monica Erbacher. Their goal is to be more active on social media.
- Kisong Kim presented the GSIC Report. They received positive feedback on the GSIC activities at the 2017 Conference. They are considering sponsoring a webinar.
- Ross Markle presented the Mentoring Committee Report on behalf of co-chairs Jerusha Henderek and Juliette Lyons-Thomas. There is a streamlined process for recruiting mentors now, and it is working very well.

- Steven Holtzman presented the Infrastructure Committee Report on behalf of the Committee. Two major topics were discussed, including working with Vieth on improvements for the coming year, and whether to renew the contract for the Conference App. Vieth has been provided a list of improvements and so far, they have been working toward them and improvements should be finalized on schedule. The Board motioned to renew the contract for the conference app.
- Craig Wells presented the Nominations Committee Report. We have some Board members rotating off the Board in the coming year and will have a few openings. Would like to encourage folks from the Teacher-as-Researcher area to run for the Board.
- Andrew Jones presented the report from the Woollatt Distinguished Paper Award Committee on behalf of chair Abby (Lau) Cahill. There a is concern about the high workload associated with this committee and ensuring that its members can fulfill their duties.
- Salika Lawrence presented the Teacher-as-Researcher Report on behalf of the committee chair, Darlene Russell. A major point of discussion was to increase TAR sessions/activities at the conference. Javarro will work with the TAR committee to come up with ideas/proposals for engaging our TAR members.
- Working budget for the 2018 conference — The Board members requested that the co-chairs prepare a side-by-side comparison noting how much was spent in different areas on the conference last year versus what they expect to spend this year. The comparison would be helpful for them as they think on how to advise and provide input on the 2018 budget. The Board agreed to have a follow-up discussion over the phone and/or email and conduct an offline approval via email.

NERA Researcher Call for Production Co-Editor!

The NERA Researcher is looking for a new production co-editor to serve a three-year term beginning in 2019. The production co-editor works alongside the content co-editor and is responsible for assembling the newsletter three times a year (Winter, Spring, and Fall). The Teacher-as-Researcher Award is presented annually by the Northeastern Educational Research Association (NERA) to a PK-12 teacher who has conducted a self-initiated classroom research project or applied research findings to inform his or her own teaching. The project must be conceptualized, developed, and implemented as part of the nominee's own teaching practices, and have had at least one cycle of trial and evaluation. The project should also be related to a clearly defined theoretical focus and represent an innovation that has led to a concrete change in practice.



Classroom teachers are invited to apply directly for this award or be nominated by NERA members, school administrators, faculty, or other education personnel familiar with the teacher's research. All applications should be submitted no later than June 30, 2018.

TEACHER-AS-RESEARCHER AWARD

The 2018 awardee will be invited to speak about the research project at a session in October at the 49th Annual NERA Conference in Trumbull, CT and will be presented with the award at that time. The award includes a plaque, NERA membership, and \$150 toward travel, meals, or lodging at NERA's conference site.

CALL FOR NOMINATIONS FOR THE LEO D. DOHERTY MEMORIAL AWARD FOR OUTSTANDING LEADERSHIP AND SERVICE TO NERA

The Leo D. Doherty Memorial Award is given to a longstanding NERA member who exemplifies the qualities that Leo Doherty brought to NERA members, his colleagues, and students over his career. The award, instituted by the NERA Board of Directors in 1981, honors the memory of Leo Doherty. He was instrumental in the development and growth of NERA as a professional association for educational research.

His leadership qualities, which were both ethical and humane, encouraged others to pursue and achieve their goals. 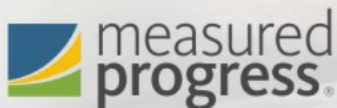

2017 Lorne H. Woollatt Distinguished Paper Award Winner

Congratulations to Maria Y. Finger-Elam, the 2017 winner of the Lorne H. Woollatt Distinguished Paper Award for the paper entitled, *Efficacy of Blended-Learning Model Literacy Intervention for Struggling Adolescent Readers*, co-authored with Marquis Dwarto of Baltimore County Public Schools. Maria Finger-Elam is Supervisor of Research the Baltimore County Public Schools.

The award-winning paper addressed the problem of a stagnation in literacy achievement at the high school level. The research evaluated a blended-learning literacy intervention for high school students reading two or more years below grade level. The study found that students who fully engaged in the computer-adaptive instructional component of the intervention had the greatest gains in reading comprehension skills, with some students showing three times the improvement in reading skills than expected.

Maria received a NERA travel stipend to present this paper at the 2018 meeting of the American Educational Research Association Consortium of State and Regional Educational Research Associations. The paper was rated by the award committee members on its relevance, theoretical backing, clarity, design, analytical procedures, and presentation of results and conclusion, and received very high scores in each of the criteria - earning the highest overall rating of all eligible submissions.

The Lorne H. Woollatt Distinguished Paper Award is named in honor of Lorne Woollatt, a distinguished New York State educator and NERA member. It is awarded annually, and a plaque is given to the recipient at the subsequent year's conference. Research papers from the 2017 NERA conference were submitted by their authors to the award committee for this competitive award. The NERA Mentoring Program would like to thank Juliette Lyons-Thomas for her dedicated service as co-chair over the past few years. We welcome Tanesia Beverly from the Law School Admissions Council as our newest co-chair!

The Mentoring Program strives to facilitate meaningful connections for NERA participants through two key approaches: 1) conference-based connections, and 2) an online message board through the NERA website.

The conference-based Mentoring Program has existed since 2012 and serves as a focused process to hand-select and match mentors and mentees. Each year, the Mentoring Program co-chairs collect information from members who volunteer to be a mentor or want to be mentored. Mentor-Mentee pairs are matched based on research interests, career goals, or areas of desired growth. Pairs are encouraged to communicate before and meet during the annual NERA conference. Participants in this program benefit by receiving a mentor-mentee match based on a structured and informed process, having dedicated time during the conference to meet, and being able to make new connections outside of their existing social networks.

The other approach that is offered is the mentoring message board. This service is available 24 hours a day and can be accessed via the *Mentoring Board* link listed in the *Mentoring* dropdown tab on the [NERA site](#). From there, members can sign up to be a mentor, or potential mentees can view the contact information for mentor volunteers. Using this approach, members can sign-up or reach out at any point throughout the year and have the freedom to form their own mentor-mentee relationships. This may be especially useful to members who cannot attend the NERA annual conference, or would like to set up a time to meet at another professional meeting.

In Memoriam: Mary Horan



Dear Friends,

When I first came to NERA in the early 80s, Mary Horan was the go-to person at NERA. She knew the history and had already been a member since the 70s. Some of you younger members may remember seeing Mary these past few years with another NERA alumni, Phil Archer.

I am sad to tell you that Mary died at her home in Albany, on January 4, 2018, unexpectedly. She was very excited when I saw her at NERA last October because she and her sister, Anne were going on a 3-week trip to Europe this summer and they were spending an extra couple of days in The Netherlands before taking one of those cruises down the Rhine. She knew that Ben and I live there part of the year and was hoping that we could suggest some sights they could see before sailing off on their cruise.

I spoke with her sister, Anne, who told me about Mary's great love of NERA and spoke of it often. To give you an idea of her involvement with NERA, before becoming President in 1984–85, she was a member of the Futures Committee and editor of the conference program abstracts in 1978–1979. From 1980 to 1982, Mary was the secretary-treasurer—back in the days when one person handled both of those tasks and everything was still done on paper, paid by check, registered by snail-mail, no electronic anything. She became program-co-chair with Jeffrey Dean in 1982–1983, before becoming president. In 1989 NERA finally recognized Mary for her outstanding leadership and service by awarding her the Leo D. Doherty Award. In fact, Mary was the chair of the group that first created the award after the death of Leo Doherty in 1979.

She was a graduate of Vincentian Institute, the College of Saint Rose, and earned a master's degree at the State University at Albany in educational psychology and statistics. Mary held several positions during her lengthy career at the New York State Education Department.

For those of you who did not know Mary, she was someone who was always there, always ready with an old NERA story or a piece of NERA history. She will be remembered and missed.
