In addition, we are planning a variety of engaging professional development opportunities:

**3MT Competition:** Inspired by the University of Queensland's Three-Minute Thesis Competition (3MT), this year NERA will hold its own 3MT event. Conference participants can volunteer for one of the limited spots in the competition, in which they will have three minutes to efficiently explain the breadth and significance of their research in a presentation aimed at a non-technical audience. We will have two competition groups: graduate students and professionals. Winners in each category will receive prizes! If you were not able to attend the informational webinar about the 3MT on May 1, you can view the recording of the session available on the NERA website. An email seeking contestants for each competition group will be sent in late summer.

**Webinars:** We will be hosting three webinars tied directly to the conference. The first webinar, which explained the 3-Minute Thesis (3MT) Competition, was held on May 1. (The recording is available on the NERA website.) The next two upcoming webinars in the conference series are "Key Advice for Different NERA Research Formats" and "Getting the Most Out of the NERA Annual Meeting"—these will be held in the next few months. Be on the lookout for more details!

**Professional Development Workshops:** For the third time, we are soliciting proposals for workshops. The voting system initiated last year was well received and will be continued this year to ensure that the workshop selections are membership driven. Once the workshop deadline passes (May 17, 2019), we will compile the workshop descriptions and distribute them to members for a vote. Stay tuned!

Our committees are also working hard to offer the best experience to our conference participants:

**GSIC Sessions:** This year, GSIC will be offering two different sessions. The first one, titled "*Getting Through It: Managing the Dissertation Process*," is a panel discussion that includes doctoral students who recently finished their dissertations, sharing their stories and offering tips and guidance. The second one, titled "*The Business of Our Business*," is a small workshop/panel that will explain how to incorporate yourself into a separate legal entity for business purposes, legal issues you may face when working on a grant or contracting, and how to plan for and limit your potential tax liability.

**Mentoring:** The mentoring program will provide graduate students with the opportunity to meet with professionals in the field. Mentors can provide individualized feedback on research projects and/or dissertations, as well as provide guidance during the conference.

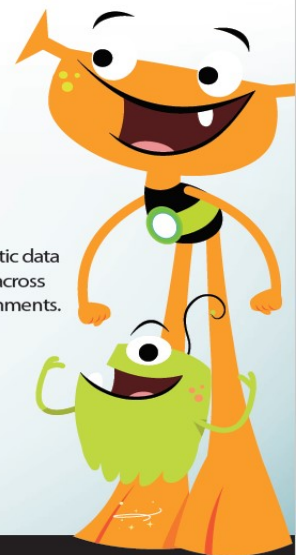

## Call for Proposals

50TH ANNUAL CONFERENCE  
October 16-18, 2019

Trumbull Marriott Shelton, Trumbull, Connecticut

As a regional affiliate of the American Educational Research Association, NERA invites proposals for our annual meeting that span all areas of educational research. We welcome proposals from new and experienced researchers and will consider proposals for both completed and in-progress research. Below you will find the conference theme and general requirements for NERA proposals as well as specific guidelines corresponding to the four session formats. ### Conference Theme: “Transformation by Design”

This is NERA’s 50<sup>th</sup> Anniversary Conference! The field of educational research has moved and been transformed in the 50 years we’ve hosted conferences. Some of those changes have been purposeful, while others have not—and just about all have had consequences. Over a thousand years ago (and in Latin), St. Jerome wrote “Good, better, best. Never let it rest; ‘til your good is better, and your better is best.” Let’s make NERA relevant a thousand years from now; the research our members conduct can still have an impact then. Recall that what is often considered the first standardized test, the civil servant evaluations of the Han Dynasty, existed two thousand years ago. With that in mind, what is the goal of your research? What do you hope it leads to? How will it impact the future? As the 2019 theme suggests, let’s be purposeful in our research so that we transform the education field *by design*. Who knows what the future holds, but it may be your work that is quoted centuries from now for how it transformed education.

As our president, Rochelle Michel has stated: “In order to enact meaningful change, we need to be intentional in our actions.” For the 2019 conference, we encourage NERA members and affiliates to be thoughtful about the changes they seek to affect, and how their research supports that transformation. **Although we STRONGLY encourage session proposals related to the conference theme, this is not a requirement for submissions.**

### Submission Requirements

- Complete information for author(s) including affiliation(s)
- Descriptive title (**maximum: 15 words**)
- Three keywords
- Description of paper to appear in conference program (**maximum: 50 words**).
- Proposal, NOT including tables, figures, and references (**maximum: 1000 words**).
- Your proposal should include study purpose, theoretical framework, methodology, results, conclusions, and educational implications.
- *Note:* Refer to the Proposal FAQ for details about the organization for proposals that may not lend themselves to each of the sections listed above
- Warning: Proposals with more than 1000 words will not be accepted.

## Call for Proposals

### Submission Format

The proposal submission form is online and accessible at the NERA website. At the time of submission, authors will be required to select from a list of descriptive keywords to categorize their proposal.

### Submission Review Process

- Proposals *must* be submitted electronically by **Sunday, June 2, 2019 (11:59 pm EST)**.
- 2 to 3 NERA members will conduct a blind review of each proposal.
- Each proposal will be judged according to the following criteria: educational or scholarly significance, perspective or theoretical framework, appropriateness of methodology, clarity of expression, and appeal to NERA membership.
- Proposal decisions will be emailed to the first authors in mid-August. Details about session dates and times will follow when the program is finalized.
- It is critical to meet the **June 2 deadline** so that reviewers have time to review each proposal, authors can be informed of proposal decisions expeditiously, and a program can be finalized and shared with members promptly.

## SESSION-SPECIFIC GUIDELINES – 2019 NERA CONFERENCE

When submitting your proposal, you will be asked to indicate which of the following session formats you prefer for your research. We encourage everyone to select more than one possible option, as selecting multiple options increases your likelihood of acceptance. Regardless of the session you choose, your paper will be subjected to rigorous peer review by NERA volunteers. As each format provides a medium for contributing your research to the field, all session formats are equally important. We hope to maintain a variety of sessions this year to maximize the educational experience for NERA members.

### 1. Individual Presentations

#### a. Individual Paper:

Proposals should describe completed or nearly completed research to be presented in 10-15 minutes. Sessions will be organized so that 3-5 individual presentations will be grouped according to similar research areas. In most paper sessions, a discussant will be assigned to read the set of papers in advance and present a 10-15-minute synthesis, critique, or analysis of the set of papers to spur discussion.

#### b. Roundtable:

Roundtable sessions allow maximum interaction among presenters and attendees putting greater emphasis on the discussion. Each table will have 3-5 researchers of accepted papers clustered around shared interests. Each session will have a designated chair knowledgeable of the research area, to facilitate interaction and participation, and when appropriate a discussant will be assigned to a roundtable session as well.

#### c. Individual Poster:

Proposals should describe a research project, either completed or nearly completed, that lends itself to a visual display and would benefit from informal individualized discussion and feedback. Similar to the individual paper presentations, each poster will have a discussant. Specific directions for the size of the poster will be posted on the NERA Conference website and are available in the [FAQ document](#).

### 2. Theme-Based Paper Session/Symposium

Proposals for this format should describe a set of 3-5 presentations organized around a common theme. The chair and discussant for this session format must be identified in the proposal. The format and procedure for these sessions are identical to the *Individual Paper Presentation* sessions.

## Call for Proposals Frequently Asked Questions

### **Does my research project have to be complete to be accepted to NERA?**

Not necessarily. In-progress or nearly completed research will be considered for the conference, but the researcher should show the potential of the work being ready for presentation by the date of the conference. We strongly encourage individuals to submit their in-progress work as roundtable presentations. This format facilitates greater discussion between participants and the audience, allowing you to receive input and feedback that could inform your research or help to overcome potential hurdles.

### **How are the descriptive proposal keywords used?**

These terms are used in several ways. Specifically, they will be used to match the proposals to the appropriate reviewers, to place the proposal in the best-fitting session, and to assign an appropriate discussant to the session. Please select the descriptor that is the best match for your proposal as your first choice and two additional descriptors as next-best options.

### **What is the review process like?**

Reviewers are NERA member volunteers, who have self-identified as being willing to review proposals in the same topic area as the proposal keyword. The conference co-chairs make final decisions, based on both the reviews and availability in the conference program.

### **When will my research paper need to be ready?**

Discussants must be able to review research papers before the session in order to prepare properly for discussion. You will be asked to email your research paper to the discussant not later than October 1.

### **Will a projector and laptop be available in my session?**

Institutional sponsors will be supplying LCD projectors for each session. Arrangements only need to be made to have a laptop present at the session. The chair of the session will arrange the laptop and file transfers to the laptop by email before the session. Presenters are expected to cooperate with chair requests.

### **What if I am accepted to NERA, but I am unable to attend NERA when the time comes?**

Submitting to NERA is a sign that you intend to attend the conference if accepted. If something prevents you from being able to attend, and co-authors or colleagues cannot present in your place, you must withdraw your presentation *before* the session by emailing [NERA.CoChairs@gmail.com](mailto:NERA.CoChairs@gmail.com).

### **What size should my poster be?**

Easels with foam display boards will be available for poster presentations. Poster size should be no larger than 36 x 48. The display should be easily read and clear from a distance of at least 3 feet from the board. The title, author, and affiliation should be in a 36-point font or larger. The rest of your lettering should be in a font of at least 28-points. Be sure to include diagrams, figures, photos, bulleted text, or other visuals that describe your research. More information regarding posters will be posted on the NERA website. Presenters should also prepare four PowerPoint slides (maximum) which will be shared electronically prior to the poster session to give attendees a short preview/overview of each study.

### **You have several session options for submitting proposals. Are any considered more rigorous than others?**

No. All formats are peer-reviewed methods for disseminating your research. The rigor of the peer review process is the same for **all** proposals submitted to the conference. Peer review allows NERA to maintain an appropriate quality level for the experience of those presenting their research, as well as those receiving the research.

## Frequently Asked Questions

### **What are the submission parameters for theme-based paper sessions/symposia?**

Those presenting proposals for theme-based paper sessions or symposia are required to submit only one proposal for all papers in the session, within a maximum of 1000 words. The submission should include a description of how the papers are related to each other, as well as a short description of each of the papers that are included in the session. Lastly, proposers can indicate within the submission that they are submitting a theme-based paper session/symposia.

### **What is the role of the Chair?**

The role of the chair is to facilitate the organization of the presentation session. Duties may include collecting the papers, communicating with authors, managing audio/visual equipment, and ensuring the timeliness of the session. In some cases, the chair would assist in facilitating discussion among the audience members and authors.

### **What is the role of the Discussant?**

Discussants are responsible for drawing from their expertise to comment on papers and presentations. The goal is to provide professional and constructive criticism and raise issues for broader consideration that connect to the works.

### **How do roundtable sessions work?**

Roundtable sessions offer the most opportunity for interactions among presenters and participants. Three to five researchers with similar interests are assigned to a table, along with a moderator with some expertise in the topic area. Individual researchers do not make a formal presentation as in a paper session but may provide a brief overview of their work and specific issues that they would like to discuss. The majority of the time during a roundtable session should be devoted to discussion among the assigned researchers and the other participants.

### **Where can I go to determine the conference registration fees?**

Registration fees are posted on the NERA website during the latter half of spring. There are three cost brackets: Professional, Retirees, and Students. Late fees are instituted after October 1. All registrants must also be NERA members. More information about membership and dues can be found on the NERA website ([www.nera-education.org](http://www.nera-education.org)).

### **Is there a special room rate at the conference hotel?**

Yes, NERA negotiates a special room rate for their members each year at the conference hotel. ## NERA Mentoring Program Update

The Mentoring Program strives to facilitate meaningful connections for NERA participants through two key approaches: 1) conference-based connections, and 2) an online message board through the NERA website. The conference-based Mentoring Program has existed since 2012 and uses a focused, hand-selected match-making process. Each year, the Mentoring Program co-chairs collect information from members who volunteer to be a mentor or who want to be mentored. Mentor-Mentee pairs are matched based on research interests, career goals, or areas of desired growth. Pairs are encouraged to communicate before and meet during the annual NERA conference. Participants in this process benefit from receiving a structured and informed match, having dedicated time during the conference to meet, and being able to make new connections outside of their existing social networks.

The other approach that is offered is the mentoring message board. This service is available 24 hours a day and can be accessed via the *Mentoring Board* link listed in the *Mentoring* dropdown tab on the [NERA website](#). From there, members can sign up to be a mentor or potential mentees can view the contact information for mentor volunteers. Using this approach, members can sign-up or reach out at any point throughout the year and have the freedom to form their own mentor-mentee relationships. This may be especially useful to members who cannot attend the NERA annual conference or would like to set up a time to meet at another professional meeting.

The co-chairs will be sending information this summer about how to participate in the conference-based Mentoring Program. ## The Graduate Lounge

Like many people, I have become enraptured by the world of George R. R. Martin’s *Game of Thrones* series. Whenever I meet someone who has the same level of passion and zeal for the series, we usually end up talking about our favorite episodes. This usually drives the non-*Game of Thrones* people around us a little bit insane with references that no layperson could even hope to understand.

My favorite character in the show is Samwell Tarly. Samwell Tarly’s father was renowned as one of Westeros’ finest military commanders and tried to raise Samwell in his stead. Samwell’s complete lack of abilities made his father disown him. Instead, Samwell pursued his interest in scholarly pursuits and eventually ended up at the Citadel, the home of scholars who advise the lords of the Seven Kingdoms on matters scientific, medical, and historical.

In today’s climate, educational researchers sometimes live in this Citadel-type of environment. We talk to each other about methodology, approaches, and things so nuanced and specific we can sometimes lose focus on the larger issues at hand. We have so much ready access to knowledge; we can forget that sometimes this wasn’t always the case.

In one storyline, Samwell met a man who was suffering from what was considered an incurable disease. Through his research efforts, he discovered a potential cure and presented to the elders at the Citadel who forbade Samwell from attempting the cure. Having confidence in his methods, Samwell disobeyed the leaders and went on to cure the man.

While we are unlikely to face such dramatic life or death decisions, there is an important lesson we can glean from this small story. All of us, especially new practitioners and graduate students, need to present and share our research with our colleagues. We need to share what we have discovered and what we have found so others can build off our knowledge.

That’s where NERA comes in. Our conference and annual meeting give graduate students from across the country the opportunity to share their work in a collegial environment. The call for proposals is available, and I strongly urge you to submit a research paper and attend as many sessions as you can. This is the time to share what you know, and have a chance to receive guidance and support from some of the most talented researchers in the educational field. Do not miss this opportunity!
