2. The second thing I want to mention is that the theme for this year's conference is "Educational Research for the Good of Society." There are many things that are happening in education. Policy makers have always talked about education being an investment for the future of our society. Even though there is a lot that needs to happen in order for us to see the fruit of our labors as educators positively impact all students and our society, there are many efforts to realize this. We are fortunate to have two keynote speakers who can speak directly to what's happening in education now in order to improve our society. We are privileged to have Governor Roy Romer and Professor Diana Pullin, Boston College as keynote speakers. You will not be disappointed by their talks and we will all gain valuable insights from them.

Additionally, we have some outstanding workshops by world-renown experts. The workshop leaders are not only excellent presenters and trainers, but also have contributed to the scientific literature associated with the topics of their workshops. 4. Finally, as we have our 42<sup>nd</sup> conference, it is important to remember and learn from the history of our organization and of history more broadly. The topics and issues that were discussed, debated, and addressed in the past can help inform today's conversations and efforts to find solutions. In one approach to address this at this year's conference, an invited panel of past presidents will provide their wisdom and input.

In closing, I encourage all members to become involved in our organization; this is your organization and its growth is a direct representation of our membership's involvement. I look forward to seeing you all at our annual conference in Rocky Hill, CT. In 1990, NERA renamed its distinguished paper award to honor Lorne H. Woollatt, a distinguished New York State educator and an active member of NERA. The award, now known as the Lorne H. Woollatt Distinguished Paper Award, is presented annually to a NERA member whose paper is deemed exemplary by the Award Committee.

Only one paper can be selected, so the Committee is looking for an outstanding paper. The winning paper will automatically be accepted for the 2012 AERA Annual Meeting as part of a session sponsored by the AERA/SIG: Consortium of State and Regional Educational Research Associations (SRERA). The award also includes a monetary stipend to help defray the recipient's travel expenses to AERA.

Please send one BLIND copy of your paper and one copy with your name and the following information: affiliation, address, email address and phone number.

Please note that the paper is to be based on your NERA presentation and should not include information that differs substantially from that which you actually presented at the NERA conference. Papers in the Research-in-Progress sessions are not appropriate for submission. In addition, papers should be limited to no more than a total of 20 double-spaced pages (not including Tables/Figures or References).

### Get Mentoring at NERA

NERA gives educational researchers the chance to support one another and improve their work. As part of that mission, NERA started a more formal mentoring program that has matched seventeen graduate students with mentors at our last two conferences.

It's too late to apply for mentoring at our 2011 conference; we have already found mentors for the eight students who requested them. If you are a graduate student, however, please consider taking advantage of this program in 2012. We accept applications over the summer, and match as many students as we can. Graduate students have the chance to share up to 20 pages of work in progress with a NERA mentor, a more experienced scholar, at our annual conference. These scholars spend 30 minutes meeting one-on-one to foster students' growth. Graduate students already have advisors, classes, and many sources of support at their own university; however, NERA mentors can provide additional perspective on draft dissertation proposals, Masters thesis chapters, or any kind of work which would allow you to share your progress and current limits with a friendly, supportive scholar. #### Call for Papers: Modern Modeling Methods Conference 2012 University of Connecticut May 22-23<sup>rd</sup>, 2012

The Modern Modeling Methods (M<sup>3</sup>) conference is an interdisciplinary conference designed to showcase the latest modeling methods and to present research related to these methodologies. The second annual M<sup>3</sup> conference will be held May 22-23rd, 2012 (with a preconference on May 21<sup>st</sup> and a post conference on May 24<sup>th</sup>). Keynote speakers for the 2012 conference include Donald Rubin, Peter Bentler, and Jack McArdle.

We are currently soliciting both methodological research papers and papers that illustrate methodological techniques in the area of modeling, broadly defined. Papers related to multilevel modeling, structural equation modeling, mixture modeling, and longitudinal modeling are especially encouraged.

Conference proposals for the Modern Modeling Methods conference may fall into one (or more) of four categories: Methodological Innovation, Methodological Application, Methodological Illustration, or Methodological Evaluation. Methodological Innovation proposals introduce a new technique. Methodological Evaluation proposals present the results of empirical research evaluating a methodology. Most often, these will involve simulation studies. Methodological Application proposals present the methods and results of a real research study in which the technique was used. Methodological Illustration proposals provide a pedagogical illustration of when and how to use the technique; these papers are designed to help the audience be able to implement the technique themselves. Methodological research proposals should be no longer than 1000 words and should include purpose, background, methods, results, discussion, and significance. Methodological illustration papers should be no longer than 1000 words and should include a description of the methodology to be illustrated as well as an outline of the paper/talk. Proposals for the 2012 conference are due January 5, 2012. Notifications of presentation status will be emailed by February 6, 2012.
