



The President's Message

discuss a topic of interest, it can lead to collaborations on future projects. It also allows for discussion of topics that may not be represented in the formal program. After looking through the conference program (which will be released in September), think about whether there are any topics which you would like to discuss and bring your ideas with you to the conference. I am looking forward to these sessions and the ensuing discussions.

Whenever I attend a conference, I always wonder why the particular invited speakers were selected. In that spirit, I wanted to share my "why." Each of the invited speakers for this year's annual conference is a person whom I have personally found to be transformative in their respective fields, while also reflecting the backgrounds and interests of the NERA membership and the broader fields of educational research and measurement.

Each of our three keynote speakers has been leading transformation within their respective areas of specialization. On Wednesday, October 16th, Dr. Monika Williams Shealey will talk about the transformational work that she has done at Rowan University. I met Dr. Shealey when we were on the faculty in the College of Education at Florida International University. At that time, Dr. Shealey spoke about her goals to become the dean of a college of education and be a champion for change. Dr. Shealey's accomplishments include establishing the Center for Access, Success, and Equity (CASE) in the College of Education at Rowan and founding Project IMPACT (Increasing Male Practitioners and Classroom Teachers), a program that aims to increase the representation of males from racially and ethnically diverse backgrounds in the field of education. Dr. Shealey now leads Rowan's newly created Division of Diversity, Equity, and Inclusion that brings together departments and programs to develop initiatives designed to address issues of access, equity, and inclusion across all of the University's campuses. This transformational work will only happen with a clear design and plan in place. I am looking forward to hearing all about it!

On Thursday, October 17th, we will have the pleasure of hearing from Dr. Alina von Davier, who is the Senior Vice President of ACTNext, which is an innovative multidisciplinary unit within ACT. She has brought together team members with diverse educational backgrounds and is applying a variety of theoretical and data-driven computational methods and statistical modeling of multimodal, large-scale assessment data. This has allowed her and her colleagues to not only develop innovative solutions to challenging problems, but to change the very ways in which we traditional think of assessment. Creating a new area within the psychometrics field and bringing together researchers with broad backgrounds ranging from psychometrics, learning sciences, software development, artificial intelligence, and machine learning, takes a transformational vision for the field of educational measurement and assessment. When Alina was at the Educational Testing Service (ETS), I had an opportunity to work with her and see the beginning of her work within Computational Psychometrics. Dr. von Davier's Center for Computation Psychometrics at ETS was a way of acknowledging that in order for the field of psychometrics to move forward, we needed some new and innovative thinking. In the spirit of collaborative problem solving, Dr. von Davier understood the importance of bringing new backgrounds and experiences to the table to engage in how to take advantage of the new types of assessment data available to the field. All of this was done from a position firmly grounded in the learning sciences. I also saw the way in which Dr. von Davier supported and advocated for her team in their projects, assisted them in getting funding to support their work, and collaborated with them on research projects. Again, these things do not happen on their own, and it is with transformational leaders like Dr. von Davier that these things are actualized. Part of this transformation is getting others to buy into the vision and give their support, which is not easy. I can't wait to hear more about Dr. von Davier's journey as she continues to be such a transformational leader within the field of psychometrics.

On Friday, our third keynote speaker will be Dr. Ezekiel Dixon-Román, associate professor of Social Policy & Practice at the University of Pennsylvania. Although

- **Dr. Mariola Moeyaert,** Assistant Professor of Statistics at the University at Albany, received an Early Career Award from the Institute of Education Sciences (IES), part of the U.S. Department of Education.
- The Early Career Awards in Statistical and Research Methodology in Education are highly competitive, with only nine prior projects being funded since 2014. The project is titled, Assessing Generalizability and Variability of Single-Case Design Effect Sizes using Multilevel Modeling Including Moderators.
- The project will uncover innovative methods that can be used to quantitatively summarize small-N studies such as single-case experimental design (SCED) studies. The IES early career award will contribute significantly to evidence-based research, theory, and practice by accumulating this scientific knowledge using multilevel meta-analytic modeling.

trained in the social sciences and psychometrics, Dr. Dixon-Román's program of research is on the cultural studies of quantification, education, and critical theories of difference. Combining theory with methodology, Dr. Dixon-Román asks us to push the envelope and question some of the foundational principles within the field of psychometrics; for example, notions of validity. Dr. Dixon-Román and I were in the same cohort in the psychometrics program at Fordham University. I have had an opportunity to witness his questioning of the status quo within our field and looking for ways in which he could move the field forward in our thinking about psychometrics, assessment, and the impact of how assessment-related decisions affect various populations of students who have been traditionally underrepresented and have different lived experiences. I invite us all to embrace this challenge as Dr. Dixon-Román shares some of his thinking on what kind of transformational changes are needed within the field of psychometrics to help us advance the field, and make sure that we are appropriately serving and providing opportunities to all learners.

We also have an exciting invited panel who will speak about their experiences as it relates to the conference theme. The invited panel includes Alina von Davier, Senior Vice President of ACTNext, Kristen Huff, Vice President of Assessment and Research at Curriculum Associates, and Rebecca Zwick, Distinguished Presidential Appointee in the Psychometrics, Statistics, and Data Sciences area at ETS and Professor Emerita at the Gevirtz Graduate School of Education at UC Santa Barbara. The panel will be moderated by Dr. Ellen Forte, CEO & Chief Scientist of edCount, LLC. They are each amazing in their own right, but you will have to come to the conference to hear more about them and all of the other engaging sessions that we have planned for this year's conference.

When these amazing individuals agreed to be invited speakers at this year's conference, I literally did a dance around my home, from room to room, hands in the air, shouting: Yes! Yes! I may have even shed a few tears of joy (you get the visual, I'm sure). I am looking forward to sharing the excitement that I felt with all of you at this year's 50th Annual Conference! Woollatt Distinguished Paper Award: Call for Best Paper Award Submissions

If you are presenting at the upcoming NERA conference, consider submitting your paper to be considered for NERA's "Best Paper" award – the Lorne H. Woollatt Award. This award is named in honor of Lorne H. Woollatt, a distinguished New York state educator who published *The Evolution of State-Local Governmental Relationships* in New York State in 1948 and was an active member of NERA.

Taking a moment to submit your paper if it is eligible could be well worth it. The first author of the award-winning paper receives a \$500 stipend to travel to AERA and present their work at the American Educational Research Association conference in San Francisco (April 17-21, 2019) during one of the Distinguished Paper sessions of the Consortium of State and Regional Educational Research Associations.

The recipient of the award is chosen by a committee of NERA members who review the papers that were entered into the competition. Each submitted paper is scored by award committee members on the importance of the topic and need for the study, the quality of the research design, data analysis, results reporting, and conclusions and the contribution the research findings make to the knowledge-base of the field. To be considered for the award, a paper must meet the eligibility criteria of being a 15-20 page, APA-style manuscript of educational research that was presented at the 2019 NERA conference.

The Lorne H. Woollatt Distinguished Paper Award Committee invites presenters at the 2019 NERA conference to enter their research papers into the competition by sending an email to Abby Cahill at lau.abigail@gmail.com no later than **November 15, 2019**. In the email, please indicate the 2019 NERA conference session in which the paper was presented and attach two copies of the paper as follows: one copy should include the names, affiliations, and email addresses of each author on the title page, and one copy should not include any author information on the title page.

At the upcoming NERA conference award ceremony, the committee looks forward to recognizing the 2018 winner, Katie Filling from Baltimore County Public Schools. Her paper entitled, *Ensuring Equity: Local School System's Policies and Practices Related to Supporting Homeless Students and Families*, was co-authored by Maria Finger-Elam, also of Baltimore County Public Schools.

Fall Webinar Series from Buros Center for Testing: Cultural and Linguistic Considerations When Developing, Adapting, and Validating Measures

Professional standards and guidelines encourage the consideration and inclusion of individuals from diverse cultural and linguistic backgrounds in all aspects of testing. However, meeting this goal presents many unique challenges. When these recommendations remain unaddressed or do not incorporate methodologies promulgated in the literature, test results may be misinterpreted and misused.

This webinar series will highlight the expertise of an interdisciplinary group of scholar-practitioners engaged in this work from school, forensic, educational, and clinical/counseling psychology to encourage the practice of standards-aligned methodologies and processes. These scholars will share empirically-based recommendations, best practice examples, and case studies that will assist with the development, adaptation, and validation of measures used with individuals from culturally and linguistically diverse groups.

- **Dr. Guillermo Solano-Flores (September 24, 2019, 11:00 am 12:30 pm CDT)** will discuss emerging methodologies that address the intersection of culture, language, and testing as critical to fairly assessing students classified as ELs. These new developments build on current knowledge from the fields of psychometrics, sociolinguistics, sociocultural theory, and social semiotics.
- **Dr. Joseph Rios (October 1, 2019 11:00 am 12:30 pm CDT)** will discuss how to improve the validity of inferences made from adapted tests by addressing recommendations for test development, such as identification of appropriate test translators and judgmental designs for evaluating translation quality and discussing quantitative as well as qualitative methods for investigating potential sources of translation bias (construct, method, and item bias).
- **Dr. Rebecca Weiss (October 24, 2019, 12:00 1:30 pm CDT)** will use guidance from both psychology and language studies to review essential considerations and recommendations when using interpreters in psychological evaluations. Ethical responsibilities, legal requirements, logistical realities, and best practices will be reviewed.
- Dr. James Allen (November 5, 2019, 11:00 am 12:30 pm CST) will discuss emergent scientific
 considerations and ethical concerns and resulting psychometric operating characteristics, internal
 structure, and external validity of two measures that were initially adapted then revised to produce
 culturally-grounded measures for suicide prevention of indigenous youth.
